

## Statement From Arizona Department of Environmental Quality

Via email; June 2024

"In Arizona, septic tanks do not have to be certified, registered, or approved through the State if they meet the requirements of the rule in the Arizona Administrative Code Title 18, Chapter 9 under R18-9-A314.

A septic tank manufacturer can manufacture and sell septic tanks in the State so long as they meet the requirements of R18-9-A314. The manufacturer must provide the Manufacturer's Certificate of Conformance with each sale of the tank as required by R18-9-A314(3)(d). You can find the Manufacturer's Certificate of Conformance at:

If the tanks that you manufacture meet the requirements of R18-9-A314, then there is no need to let the state know the State. You must provide the Manufacturer's Certificate of Conformance with each sale of the tank."
